



INFORMED CONSENT

I voluntarily consent to participate in a supervised exercise program through Mind Body Peak Performance and Mind Body Wellness Camps.

It has been suggested to me by a representative of Mind Body Peak Performance that I seek medical clearance before beginning this or any exercise program.

I understand that the activities I will engage in are designed to place a gradually increasing workload on my cardiovascular system. The reaction of the cardio respiratory system to exercise activities can't always be predicted with complete accuracy. There is a risk of certain changes that might occur during or following the exercise. These changes might include, but are not limited to, abnormalities in my heart rate, blood pressure or breathing. I understand that I am responsible for monitoring my own condition throughout the exercise class and should any unusual symptoms occur, I will stop my participation and inform the instructor.

I understand that the activities I will engage in are also designed to place a gradually increasing workload on my musculoskeletal system. My program may consist of flexibility and strength exercises (including weight lifting, rubber band exercises, and abdominal exercises) and endurance activity (such as walking, jogging, bench stepping, and rope skipping as tolerated). I do not have any musculoskeletal problems that would preclude me from participating in the aforementioned activities.

I have been made aware that there are inherent risks to outdoor exercise activity largely uncontrollable by Mind Body Peak Performance and its representatives. These risks include, but are not limited to: changing road conditions (fast cars, pot holes, branches and other tree debris), exhaust fumes, unleashed animals, slick pavement, slippery or uneven grass and inclement weather. I understand that I have the right to terminate an outdoor session if I feel the conditions are unsafe. I understand that my trainer has the right to do so as well, and will exercise this right when conditions deem it necessary.

Photo and Video release: In connection with my participation in Mind Body Peak Performance Training, Mind Body Wellness Camps, Health & Fitness Classes, Programs, or Workshops, I consent to the use of my photograph and video or other likeness in the promotional and other materials of Mind Body Peak Performance Training, Mind Body Wellness Camps without payment or other consideration made to me.
